Title VI of the Civil Rights Act of 1964

Title VI provides that: "No person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity receiving federal financial assistance."

Title IX – Education Amendments of 1972 Title IX reads that: "No person in the United States, shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving federal financial assistance."

# Rehabilitation Act of 1973 Sections 503, 504 and 508

- The Rehabilitation Act of 1973 requires access to programs and activities that are funded by Federal agencies.....
- Section 503 Nondiscrimination under Federal grants in employment
- Section 504 of the Rehabilitation Act Nondiscrimination under federal grants programs from participating in programs or receiving benefits.
- Section 508 of the Rehabilitation Act Electronic and Information Technology (accessibility)

- Eliminate county CR files

- Parity used as diagnostic tool for counties
- Only question to answer is ADA




