The School of Natural Resources (SNR) at the University of Tennessee Institute of Agriculture (UTIA) invites applications for the position of Extension Specialist in Outdoor Recreation and Education. This is an exempt, fulltime, 12-month, non-tenure track, staff position. The Extension Specialist has primary responsibility for developing education and engagement programs statewide to encourage, promote, and support nature-based outdoor recreation with a focus on hunting, fishing, boating and recreational shooting.
